Dear President, Deputy-President, Minister of Health, Minister of Finance, Speaker of the National Assembly, Chairperson of the National Council of Provinces, Chairperson Select Committee on Social Services, Premiers and Health MinMEC members

RE: A FULLY-COSTED, EMERGENCY PLAN TO AMELIORATE THE U.S. FUNDING CUTS

We are a group of civil society organisations and individuals who, together with the Global HIV Treatment Coalition, are eager to engage urgently on the Government's Plans for Emergency HIV Funding. We are determined not to let people die, and many of us are veterans of the Treatment Action Campaign.

The United States has placed the more than [20 million people living healthily with HIV on ARVs](#) supported by PEPFAR on death row through its funding cuts and the resulting interruption to access to ARV treatment. This is having a catastrophic effect on individual health as well as public and global health.

Since January 2025, South Africa has lost approximately \$261 million (R5.2 billion) in public health and research funding from PEPFAR/USAID and the National Institutes for Health for our HIV/TB programmes. We also know that [“due to the ongoing challenging funding landscape”](#), by the end of June 2025 South Africa will receive a “reduced allocation and revised indicative budgets” for the Global Fund's Grant Cycle 7 (GC7).

These funding cuts are devastating.

Recent modeling studies suggest that:

“Over 2025-2028, discontinuing PEPFAR funding in South Africa without replacement by SAG would result in 150,000-296,000 additional new HIV infections (29-56% increase) and 56,000-65,000 additional AIDS-related deaths (33-38%). Permanent discontinuation of currently PEPFAR-supported services over the next 20 years increases this to 1.1-2.1 million additional new HIV infections and 519,000-712,000 additional AIDS deaths” - [Meyer-Rath et al.](#)

These figures exclude the impact of funding cuts of NIH and Global Fund budgets.

Instead of relying on the energy, knowledge, expertise and power of civil society and movements in South Africa on how to ameliorate these cuts and draft an urgent Plan to do so, our country’s political leaders have argued while box-ticking its “consultations with civil society and donors”. The Health Ministry has not taken concerted action as evidenced by occasional comments to the press and [one public briefing](#) to Parliament by Minister Motsoaledi on 6 Feb 2025. Deputy-President Mashatile, who is also the Chairperson of the South African National AIDS Council, claims to be seeking funding from the national lottery. Parliament, the National and Provincial AIDS Councils, and everyone else in the country are in the dark regarding the emergency plan and action required.

It is clear that South Africa urgently needs a fully-costed, emergency HIV plan.

We believe this Plan should include the following components:

- a. Fully-costed provincial and national plans that focus on key programmes that will prevent infection, reduce illness and save lives through the economic and efficient use of the emergency funds from Treasury;
- b. Support for those currently on anti-retroviral and TB treatment, including adherence programmes and interventions to support bringing people back into the system;
- c. Focus and resources for HIV testing and prevention including active case-finding and sustained access to PrEP and PEP;
- d. Reinstatement of services for “key populations” while at the same time continuing education on equality, dignity and privacy in the health services;
- e. Strengthened data collection, management and oversight including continued support for community-led monitoring.

Against this background, our urgent requests are as follows:

1. The Minister of Health provides information on the current impact of the US funding cuts from, among others, health districts, the National Health Laboratory Services and the National Department of Health;
2. The Minister of Health provides the details of National Government’s emergency plan to address the HIV funding crisis;
3. The Provincial Health MECs provide the details of the Provincial Governments’ emergency plans to address the HIV funding crisis; and
4. National Government agrees to meet with civil society and Health sector leaders to review the emergency plan to address the HIV funding crisis.

We look forward to receiving the plans and request for these to be forwarded by 07 July 2025 (2 weeks from now). After reviewing the plans we would appreciate a meeting at your soonest convenience.
