

SUPPLEMENTARY REPORT ON THE STATUS OF FUNDING OF NON-PROFIT ORGANISATIONS IN GAUTENG FOR THE 2024/25 FINANCIAL YEAR AS ORDERED BY THE HONOURABLE OPPERMAN J ON 22 MAY 2022

INTRODUCTION

- 1. The Purpose of this submission is to provide a report on the Gauteng Department of Social Development's ("the Department") compliance with the Court Order dated 22 May 2024 ("the Order").
- 2. The Department provided a report to the Gauteng Care Crisis Committee ("GCCC") on 10 June 2024 regarding its compliance with the abovementioned Order as well as the information required in terms of paragraph 4 of the Order. This supplementary report provides further details on the Department's compliance with paragraphs 1 to 3 of the Order as undertaken by the Department at a meeting on 13 June 2024 before the Honourable Opperman J.

THE COURT ORDER

- 3. The Order issued on 22 May 2024 provides that -
 - "1.The Department of Social Development Gauteng (the "Department") is ordered to conclude the adjudication of applications submitted by Social Work Organisations ('SWOs') for funding in terms of the advertisement issued by the respondent on 01 November 2023 and accordingly inform all SWOs who applied for funding as to the outcome of their applications for funding, by 24 May 2024.
 - 2. Subsequent to the conclusion of the adjudication of applications referred to above, the Department is required to issue draft service level agreements to the successful SWOs by 30 May 2024 and seek to finalise the conclusion of the service level agreements as soon as reasonably possible. If any disputes arise between the respondent and successful SWOs about the terms of the service level agreements, the Department must make good faith and reasonable efforts to resolve such disputes.
 - 3. The Department is ordered to pay all funding due and payable to the SWOs for the first quarter of the 2024/2025 financial year in

accordance with the provisions of the concluded service level agreements with successful SWOs within seven days of the return of the those signed service level agreements to the Department by the SWOs.

- 4. An order is granted, directing the respondent to furnish a report by 7 June 2024 to the Applicant setting out:
- 4.1. A list of the SWOs approved for funding for the fiscal year of 2024/2025.
- 4.2. On request, in relation to SWOs who have not been approved for funding for the fiscal year of 2024/2025, the Department will provide reasons for the refusal of an application within 30 calendar days of the date of decision.
- 4.3. The monetary value of the subsidies awarded to each SWO approved for funding for the fiscal year of 2024/2025.
- 4.4. A list of SWOs which have concluded service level agreements with the Department and the date on which the funding was or will be advanced.
- 4.5. A list of SWOs which have been approved for funding by the Department and have not concluded service level agreements.
- 5. The Applicant or Respondent may approach this Honourable Court on supplemented papers for further relief."

THE DEPARTMENT'S COMPLIANCE

PARAGRAPH 1 OF THE COURT ORDER

4. The Department received a total number of 1723 applications. Subsequent to the adjudication process, which was substantially concluded on 31 March 2024 and finally concluded on 7 April 2024, 1329 applications were successful and 394 were unsuccessful.

- 5. On 24 May 2024, the Department had substantially complied with paragraph 1 of the Order. On even date,875 NPOs had been notified regarding the outcome of their applications.
- 6. The Department utilised different methods of notifying the NPOs. In this regard a number of the NPOs were informed of the outcome of their applications by telephone, some NPOs were sent emails and those who are the subject of an investigation were provided letters.
- 7. It is important to note that, on 24 May 2024, the Department was unable to reach 133 NPOs as a result of their contact details not working, a failure by the NPOs to provide contact details or the Department's team incorrectly capturing the contact details. A list of the NPOs that were unreachable is set out in paragraph 38. The Department has addressed this issue and, to date, all the NPOs have been notified accordingly. However, should there be NPOs that insist that they have not been notified regarding the outcome of their applications, the Department invites such NPOs to engage the Department directly to ensure that this is immediately addressed.

PARAGRAPH 2 OF THE COUR ORDER

- 8. In light of the media statement released on 28 May 2024 by the Gauteng Premier, Mr Panyaza Lesufi and the undertaking by the Gauteng Provincial Government to pay the qualifying NPOs for the first and second quarters in terms of the existing 2023/2024 SLAs as a stop gap measure, the Department adopted a two-fold process in respect to the issuing of SLAs.
- 9. It is important to note that prior to the abovementioned media statement, the Department issued 1105 draft SLAs to qualifying NPOs for the 2024/2025 fiscal year in accordance with the Order. Subsequent to the undertaking in the abovementioned media statement, the Department began the process of issuing interim SLAs to NPOs which were successful in the 2024/25 adjudication process and had received funding in the 2023/2024 fiscal year.
- 10. Accordingly, all new applications *i.e.* those which were not funded in the 2023/2024 fiscal year are subject to the 2024/2025 SLAs.

- 11. In an effort to expedite the payments to NPOs to ensure that the beneficiaries are not adversely impacted by the delays, the Department prioritized issuing interim SLAs to the NPOs which were successful in the 2023/2024 fiscal year as there had already been an established relationship with these NPOs, furthermore, their details were already captured in the Department's records and as such, payments could be processed expeditiously.
- 12. On 30 May 2024, a total of 1106 draft 2024/25 SLAs had been issued to successful NPOs and to date 1136 draft SLAs have been issued.
- 13. The Department is at this stage not able to indicate the number of interim SLAs issued. However, a total of 849 interim SLAs have been signed.
- 14. Furthermore, the Department confirms that to date, since the submission of the initial report, the following NPOs have been provided with SLAs:

PARAGRAPH 3 OF THE COURT ORDER

Payment to NPOs subject to interim SLAS in accordance with funding from 2023/2024 fiscal year

- 15.Out of the 764 NPOs which were funded in the 2023/2024 fiscal year, the Department has paid 537 NPOs and has processed payment to 81 NPOs. The processing of payments was finalised on or before 16 June 2024.
- 16.Out of the remaining 146 NPOs which have not been paid, 68 NPOs are under investigation, 22 NPOs are non-compliant and 34 NPOs do not appear on the Department's system as having submitted applications for the 2024/2025 fiscal year. As such, 22 successful NPOs which are not under investigation and comply with the Department's legal prescripts remain to be paid. The Department has processed these payments with effect from 18 June 2024.

- 17. A list of the NPOs subject to investigation is attached as annexure "A", a list of the NPOs that are non-compliant is attached as annexure "B". Furthermore, a list of the NPOs the Department was unable to contact is set out in paragraph 38.
- 18. In respect of the NPOs that are non-compliant with the legal and statutory programme prescripts of the Department, the non-compliance includes but is not limited to issues such as the NPO not being registered accordingly, not possessing the requisite certificate in respect of the building within which they operate and the social workers of the NPOs not possessing the requisite registration certificates from councils such as the South African Council for Social Services Professions
- 19. Furthermore, the Department has provided the non-complaint NPOs with an opportunity to rectify their respective non-compliance issues. Once the non-compliance issues are addressed the Department will process payments to the respective NPOs accordingly.
- 20. In respect of the NPOs that do not appear on the Department's system as having applied for funding, the Department will invite the respective NPOs to provide the Department with proof of their applications. Should an NPO provide such proof, the Department will consider the NPOs application.
- 21. Furthermore, it is important to note that a number of 15 payments have been wrongfully made to NPOs that are the subject of investigations. The Department is in the process of recalling the respective payments.
- 22. From 10 June 2024, to date, the Department has made and/or processed the following payments:

Payment to NPOS subject to SLAs for the 2024/2025 fiscal year

- 23. In relation to new NPOs, to date, a total of 93 SLAs have been returned to the Department.
- 24. In light of the above, payments are yet to be made to the new NPOs subject to the NPOs complying with the Department's legal and programme specific prescripts.
- 25. As such, the Department endeavours to begin processing the payments to the new NPOs who have returned signed SLAs by 19 June 2024.

The Funding Process undertaken by the Department

- 26. It is important to note that the Department prioritised making payments to the NPOs it funded in the 2023/24 fiscal year on the basis that the respective NPOs are dependent on the Department's funding. Furthermore, these respective NPOs were prioritised in an effort to ensure that service delivery to beneficiaries was not impeded.
- 27. It is noteworthy that in an effort to further expedite the payments to the NPOs funded in the 2023/24 fiscal year, a number of the payments made to these NPOs were processed despite an interim SLA not being duly signed. In this regard, the Department made payments to NPOs on the basis of the NPOs having been

successful in their 2024/25 applications, the NPO complying with the Department's legal and programme specific prescripts and further not being the subject of any investigations.

Issues encountered by the Department resulting in the delay in complying with the Court Order

- 28. Notwithstanding, the Department's substantial compliance with the Order, a few difficulties resulted in the delay in fully in complying with the Order and in particular the due dates imposed by the Order.
- 29. As indicated in paragraph 7 above, the Department had difficulties contacting some NPOs to notify them regarding the outcome of their applications.
- 30. On 28 May 2024, 2 days before the due date for issuing the draft service level agreements for the 2024/25 financial year, the Department was required to implement the stop-gap measure and issue interim SLAs to the NPOs funded in the 2023/24 financial year. The parallel processes of issuing both the draft SLAs for the 2024/25 fiscal year and the interim SLAs contributed to the delays in issuing all the draft SLAs by 30 May 2024.
- 31. Furthermore, it was difficult for the Department to make payments within 7 days of an SLA being duly concluded. This was attributed to the requisite process for processing payments to NPOs.
- 32. In this regard, it is important to note that once an SLA is concluded and before the CFO processes payments, a further exercise of ensuring the NPO is compliant with the legal and programme specific prescripts of the Department is undertaken. This includes, amongst others referring the respective NPO's file to the respective region's team of social workers to ensure the NPO has the requisite certificates. Once clearance is received in relation to the compliance of the NPO, the CFO loads the payments on the Department's system and the payment is further processed by Treasury. The process from the CFO loading the payment on the Department's system to the payment being made into the respective NPO's bank account takes approximately 3 days should no issues arise.

- 33. Furthermore, prior to the Premier's statement dated 28 May 2024, the Department was required to process payments in terms of the 70/30 split clause. The processing of payments in terms of this clause which was implemented for the first time in this fiscal year resulted in delays. This was because the Department was required to load new information on its system in relation to the payment model and determined the manner in which funds were to be expended by each NPO.
- 34. As such, the process of loading new information in relation to the Department's payment model resulted in delays in processing the payments. This was another issue that resulted in the Department, as per the Premier's statement reverting to the previously utilised payment model for the NPOs funded in the 2023/24 fiscal year. This assisted in expediting the payments to NPOs because the information required by the Department's system as per the payment model was already captured.
- 35. However, the newly concluded SLAs which were on the basis of the 70/30 clause had to also be amended accordingly to align with the previous funding model. This too, resulted in further delays.
- 36. In a further effort to expedite payments, the CFO submitted a deviation request to process the payments to the NPOs funded in terms of their 2023/24 SLAs in bulk. It is important to note that although this expedited the processing of payments to NPOs, a number of NPOs were wrongfully paid. The Department is recalling such payments.
- 37. Furthermore, the Department experienced difficulties in relation to data management which resulted in data being captured incorrectly by the Department's team which was tasked with this responsibility. As such, compiling and consolidating information has been delayed. This is the reason the Department was unable to submit its report by 7 June 2024
- 38. Furthermore, the Department was unable to reach some NPOs and as such has not notified them in relation to the outcome of their applications. The NPOs are set out below:

FORENSIC INVESTIGATION

- 39. A forensic audit report ("**the report**") has been submitted to the Department which makes findings against a number of NPOs following an investigation into these NPOs. A list of the NPOs is attached hereto marked annexure "A". Furthermore, in terms of the report the respective NPOs were provided *audi alteram partem*.
- 40. As such, upon a request for reasons for the refusal of the Department to award funding to these NPOs, in terms of paragraph 4.2 of the Order the specific reasons and findings will be furnished to those NPOs.
- 41. At this stage, the Department has furnished letters to NPOs who have requested reasons detailing the specific reasons for the Department's refusal to provide funding to the NPOs and setting out the findings against the respective NPOs.

CHILD WELFARE TSHWANE - INTERIM MEASURE

- 42. As per the Honourable Judge Opperman's directive of 14 June 2024, the Department proposes that it makes an interim payment for the first quarter to Child Welfare Tshwane to ensure that the services to the beneficiaries are not impeded.
- 43. The payment has been processed by the Department and should be received by Child Welfare Tshwane during the week beginning on Monday, 24 May 2024.
- 44. It should however be noted that the above is an interim measure to address the immediate funding requirements of the organisation. However, findings have been made against the organisation following an investigation that was commissioned

by the Department and the organisation has been advised about these findings and afforded a further opportunity to make representations in relation thereto.

CONCLUSION

45. The Department has substantially complied with the Order. However, as indicated above, the Department experienced difficulties which hindered the Department's full compliance with the Order. The Department has put in place measures to ensure that complete compliance is achieved.
