recruitment of the management team, development of its policies including various guidelines and prioritisation framework, directed the investigation and litigation strategy and personally led some of the key cases, including settlement discussions with parties. He also played a key role in organizational development and supported the Commissioner in managing relationships with key stakeholders and communication. During this time, he also established the Commission's Cartels Division and a record no of cartels were uncovered and successfully prosecuted.

<u>Divisional Manager, Mergers and Acquisitions, August 2007 to November 2008</u>

This is the head of mergers and acquisitions, then the busiest division of the Commission when a record number of mergers (more than 400) were evaluated in one financial year. Work involved managing a team of lawyers, economists and industry experts in assessing the implications of the mergers in the SA economy, including their impact on public interest. He reorganised the division to focus on important cases and improve quick decision making for straight forward phase 1 mergers. He established a unit dedicated to monitoring implementation of merger remedies. He worked in mergers in all sectors of the economy.

Divisional Manager, Compliance, July 2006 to August 2007

He was the head of the division that was responsible for advocacy and communication. Advocacy entailed promoting voluntary compliance with the Competition Act by providing advisory opinions and running compliance workshops for businesses; and advocating to government and regulators to consider competition implications of laws, policies and actions. In this capacity he was also responsible for compiling annual reports and presenting to various stakeholders, key among these being Parliament. It is during this time that he led the drafting of the Commission's corporate leniency policy.
