In my understanding the driver was acquired as service rendered by Arthur's Company. The question therefore becomes what service? what policy was used to appoint it? why? and how come? and why the Company owned by a member chairperson appointed to render such service? The board in all of this was in the dark, as ~~it~~ it never met and everytime when I wanted to call a board meeting I was sworn at by him, since I was also under his employ.

In addition some of the expenses of Arthur's Companies were paid for by SAADA e.g public liability insurance, telephone bills and rental of premises from 999 music/Roadshow Marketing and

Vehicle bought with the grant were used to ferry his artists ~~and~~ signed under his label 999 music to stars e.g. his son DJ AJ

Chancee fellow board member mostly that artists were driven around by 999 music/Celebrity Services manage Merle Peltam (060-659-4896).

Cameras, printers, laptops and furniture bought by SANADA. The items ~~and~~ eventually ended up in his guest house for the benefit of his company.

As the S.G. together with the board we were sidelined in any activities of the NPO. The chairperson approved and used the NPO's funds at his own will. Thus the NPO was run as the fiefdom of Arthur Mappake. Staff were hired without the board's input, were not given contracts some if not all were also unfairly paid and fired by Arthur.

The eventual winner of the project Ms B. Thudo is a classical example of the abuse in SANADA by Arthur. This artist did not do the evaluations like all the participants in the project.
