## INTRODUCTION:

- -What happens about the lottery license is also our business as it affects the funding revenue to be generated as a result.

Perhaps you should also tell us why you have been on radio 50 702 punting HCI defending them when they haven't asked you to, what is your interest Ntate Raymond 50 tell us and South Africa what is it you stand to benefit 60

We can pull your interview from 702 if you deny this because history doesn't lie 😩
